### IMPORTANT NOTE

According to the Iranian custom laws, all incoming goods need to be customs cleared on temporary base at first (temporary import javaz). Consumers goods can be final customs cleared later on by consume javaz. If you send consumable goods (brochures, give aways, food stuff etc.) you need to calculate at first the charges for temporary import, the bond fee and later on the charges for final import clearance (import javaz).

## OUR TERMS AND CONDITIONS OF TRADING

All prices quoted in this tariff are based on current freight rates and rates of exchange and will be charged in €. Any major fluctuations occurring before the work is completed may be reflected in our final invoice.

All business is executed on basis of the German Forwarders' General Terms and Conditions of Trading (ADSp) except air transports according to the Montreal Agreement. The ADSp limit in paragraph 23 the legal liability for damage to goods whilst in the care of a forwarder to 5 Euro/kg, in accordance with §431 of the Germany Commercial Code (HGB); in the case of multimodal transports including sea transport to 2 SDR (special drawing rights) per kilogram plus, in addition, per damage or event to 1 Mio Euro or 2 Mio. Euro respectively, or 2 SDR/kg, whichever is the greater. The parties agree subsidiary, that (1) clause 27 ADSp does neither extend the liability nor the responsibility of the forwarder for agents, servants, employees or crewmembers beyond legal regulations as Art. 507 HGB, Art. 25 MC, Art. 36 CIM, Art. 20,21 CMNI for the benefit of the principal, (2) the freight forwarder as a sea carrier is only liable for fault of his own part in case of risks provided in Art. 512 paragraph 2 no. 1 HGB such as default in navigation of the ship or fire on board and the freight forwarder as a carrier defined in CMNI is relieved in compliance with the requirements provided in Art. 25 paragraph 2 CMNI such as default in navigation of the ship, fire on board and defects of vessel.
